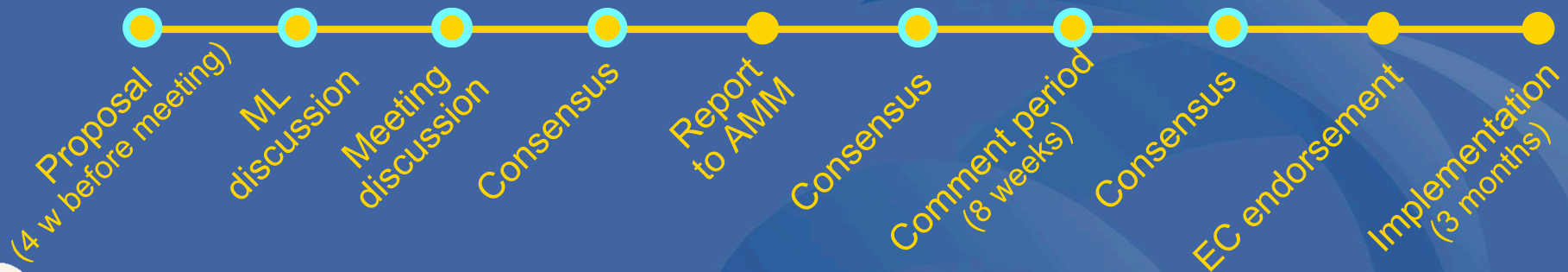

 - [prop-008-v001](#) IANA IPv4 resource request procedures (Global policy)
 - Adopted by ICANN Board in 8 April 2005 and also implemented by the RIRs
 - [prop-025-v001](#) Proposal on IPv6 IRR
 - To be implemented (full report in DB SIG)
 - [prop-026-v001](#) APNIC to publish address assignment statistics
 - Implemented (full report in DB SIG)
 - [prop-027-v001](#) The second phase of Large Space IPv4 Trial Usage program for future IPv6
 - Approval of program extension

 - 2005-5: IPv6 HD ratio
 - 2005-4: AfriNIC Recognition Policy
 - 2005-2: Directory Services Overhaul
 - 2005-1: Provider Independent IPv6 Assignments for End-sites

LACNIC community



- Global policy IPv6 allocation IANA to RIRs
 - As in other RIR communities
- Recovery of unused Internet resources
- IPv4 additional allocation policy for International ISPs
- IPv6 size management (informational OPM discussion)

RIPE community



- HD Ratio for IPv4
 - Last call 15th July 2005. No decision yet
- IP Assignments for Anycasting DNS Servers
 - No clear consensus. Await revised version of the proposal
- IPv6 Initial Allocation
 - To remove the requirement for 200 customers
 - Revised proposal is being developed



RIPE community



- IPv6 Address Allocation and Assignment Policy - definition of an "End-Site"
 - Clarify definition of an "end-site". Currently in discussion phase
- Removal of AfriNIC policies from RIPE policy documents
- Introducing DNSSEC service to the reverse DNS trees
 - Discussion extended
- Formalised policy development process implemented
