At the start of this year the EC announced a new vision and mission statement for APNIC.


#### Our vision is:

# **APNIC Strategic Plan**

- The EC has endorsed a Five Year Strategic Plan to focus efforts on our mission
- It includes specific activities to focus on:
  - Serving Members
  - Supporting the Asia Pacific region
  - Collaborating with the Internet Community
  - Supporting APNIC as a resilient organization capable of meeting our community obligations



# **Financial Objectives**

- We have been considering what is a prudent financial policy for APNIC to ensure the stability of APNIC's functions.
- We have set an immediate objective of maintaining at a minimum a cash reserve position equivalent to 12 months of operating expenses, and building this reserve to an 18 month position by 2017
- We are currently working with a reserve position of 14 months
- We aim to achieve this objective primarily through expenditure constraint rather than increasing membership fees in future budgets





# **Risk Registry**

- We want to ensure that APNIC will continue to serve the community of Asia Pacific for many years to come
- The Secretariat is now maintaining an APNIC Risk Registry that describes potential risks for APNIC and the various measures being undertaken to mitigate these risks



## Member Engagement

- The EC welcomes comments, suggestions and questions from members, stakeholders and all others with an interest in APNIC's functions and operations
- We strive to improve the ways in which we:
  - Understand and respond to the needs of our members
  - Work efficiently and effectively in our core functions of responsible address administration and accurate registry management
  - Engage with the broader Internet Governance forums to ensure that Asia Pacific voices are an integral part of the process
  - Deliver value to our members and clients
