- Continuing EC activity to:

Corporate Documents

- We have revised the APNIC Membership Agreement and Definitions Document to create a uniform agreement that meets the current needs of members
 - The revision mainly concerns the liabilities and limitations section, and the changes release members from a number of specific liabilities
 - This agreement was adopted in January 2012
- We have adopted an NIR Membership Agreement to be used from now for any further NIRs
 - Based on standard APNIC Membership Agreement
 - We are working on an NIR agreement that would be used by all NIRs

Number Council Appointment

- Andy Linton has been appointed by the EC for 2012 to sit on the Number Council/Address Council as the EC-selected council member

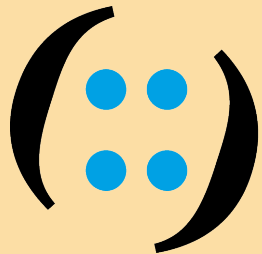
