



# Number of Vietnam Internet users




# Number of VNNIC members





# Vietnam IPv6 promotion milestones

**May 6<sup>th</sup> 2008**

The Minister of Information and Telecommunications issued Directive No. 03/2008/CT-BTTTT on IPv6 deployment and promotion in Vietnam.

**January 6<sup>th</sup> 2009**

The Vietnamese IPv6 Task Force was established, headed by Deputy Minister of Information and Communications, VNNIC plays the role of Standing Committee.

**March 29<sup>th</sup> 2011**

The Minister of Information and Communications issued Vietnam National IPv6 Action Plan.

# Project to promote IPv6 deployment in small and medium ICT enterprises (ICT SME)

**Why IPV6?** Very easy to answer.

**Why ICT SME?**

Many countries had issued their own IPv6 master plan. However, the country master plan often focus more on the critical infrastructure and the major area of the ICT industry. This status may somehow leads to the lack of awareness and capacities for ICT SME in deploying IPv6. So, ICT SME need an other IPv6 promotion channel to ensure them keep updating with the general trend.

**What will we do?**

- To perform a multilayer surveys about IPv6 deployment status among ASEAN countries.
- To build up a set of recommendations and guidelines for ICT SME to deploy IPv6 most efficiently.
