




#### [Statistics] IPv6

  - 71 out of 265 domestic IP members allocated IPv6 addresses



Addresses delegated from the 103/8 free pool cannot be transferred for a minimum of five years after the original delegation.

#### [Activities]



- Regular Checkup of IP WHOIS Information accuracy
  - Checkup by phone or e-mail twice a year for annual fee or emergency contact
  - Privacy Issue(IP administrator's personal contact info. is substituted with company's official e-mail and phone no.)
- Synchronizing WHOIS information between APNIC and KISA
  - KRNIC is regularly querying the APNIC WHOIS information for IP blocks allocated to KRNIC.
  - The WHOIS information on IP blocks which do not match between APNIC and KRNIC is updated monthly from 2017

#### [Activities]



- Asia Pacific Internet Governance Academy (2018 APIGA)
  - 2018. 7. 23~27, Chonnam National University (Co-hosts: KISA, ICANN)
  - Pre Training on Internet governance and related topics
  - Completion of course : 32 participants (16 economies in Asia Pacific region)
