Working Group - Facts

- Formed at APNIC 30, August 2010, Gold Coast, Australia
- Original Charter – To discuss specific proposals in which Governments can further develop their involvement and report back at APNIC 32 – Proposed by Mr. Rajesh Chharia
- Present strength of Working Group Subscribers – 63
- Discussion Mode:
 - On-line discussions in the working group
 - In progress report presented in AMM at APNIC 31, Hong Kong
 - Face to Face Meeting with the Members at Busan on 29th August 2011

Revised Proposal Summary

- Public Policy Advisory Committee (PPAC) in APNIC is proposed to be a multi stakeholder formal advisory body comprising of:
 - Industry / Community participants
 - Government Representatives
- PPAC is a framework to institutionalize the private ~ public engagement within APNIC on matters relating to Public Policies encompassing all the facets of Internet.
- PPAC's role will be to work with APNIC on matters related to Public Policy Issues for development of internet in the region.
- It will pro-actively advise APNIC on new policies/emerging developments in the respective regions.
- It will also provide APNIC an opportunity to participate in the policy developments processes of respective member countries.

Revised Proposal Summary

- PPAC aims to provide an interface with appropriate Governmental organizations on matters related to the Internet community.
- Advise all stakeholders to propose ways and means to accelerate the availability and affordability of the Internet in their regions.
- Discuss public policy issues to foster sustainability, security, stability and development of the Internet;
- Facilitate the exchange of information and best practices.
- Strengthen and enhance the engagement of stakeholders in existing and/or future Internet policy developments;
- Identify emerging issues and to bring them to the attention of APNIC community.
- Discuss issues related to critical Internet resources.
- Work as an advocacy group to help the Government make informed decision in overall interest of growth of internet.

Summary of Discussions

- Opinions were expressed on the Role and Importance of Government in the Growth of Internet.
- Support was extended finally to the revised proposal of engaging multi-stakeholders for the body.
- It was suggested that further deliberation to operationalize needs firming up.
- In summary, the queries were relating to understanding how the proposed committee will function.

Report / Recommendations

Report

- Consensus achieved in the Community to constitute the advisory body at APNIC.

Recommendations

- Executive Council (EC) to initiate steps to operationalize the body.
- The body be named “Public Policy Advisory Committee”.
- Discussions to continue amongst the community to work on the fine print and structure.
- The conclusive framework of the committee to be presented in APNIC 33, New Delhi
